Town of Dunn Burying Ground

Thank you for inquiring about the Town of Dunn Burying Ground. The Burying Ground is located on the southeast corner of the intersection of County Road B and Sandhill Road. It is run and maintained by the Town. While the new section of the burying ground is mowed the old, historic section is left much in its natural state. There are many native species of prairie grasses and flowers in this area, some of which are rare.

After visiting the Burying Ground and having selected a grave plot, please come into the Town Hall. We will verify that the grave plot is available. Each individual grave plot is \$900.00. A deed will be issued per each individual grave plot upon payment. Since the deed will need to be signed by both the Town Chairman and the Town Clerk, the deed will be mailed to the purchaser. Prior to burial, an **Application for Internment** (enclosed) would have to be filled out and a copy of the **Disposition of Human Remains form** would need to be sent to the Town Hall. The fee to mark out a grave or for a gravestone is \$50.00 during normal business hours and \$100.00 after normal business hours.

Town of Dunn Burying Ground Background

The Town of Dunn Burying Ground was established in 1852, though the land had been used as a burial ground by the Beebe Family before they sold it to the Town. It became the final resting place of many Civil War Veterans. Throughout its history, the Burying Ground has been left largely in its natural state. Early records mention the large oak trees and lilac bushes that remain today. Pink roses along the eastern fence line, mockorange and wildflowers including shooting stars, pussy toes, and trillium complete the picture of an early prairie cemetery. In this original state, field stones and wooden crosses marked many of the gravesites, in addition to the surviving marble headstones. By 1890, the half-acre cemetery was deemed full.

Nearly a century later, the Dunn Park Commission expressed their desire to restore the Burying Ground, conducted a historical study of the individuals buried there, and developed guidelines for its continued preservation and maintenance. In January or 1984, the Town Board confirmed the Park Commission's appointment of Mary Jo Reynolds, Marion Berman, Jackie Jeardeau, Loraine Hawkinson, Margaret Lalor, Lottie Halvorson, Ann Taylor, and Pam Crapp to the newly created Cemetery Task Force. They set to work quickly, contacting the Wisconsin State Old Cemetery Society. The next year, the Committee worked with the Sand Hill Veterans Association to restore the grave markers and grounds. Despite setbacks, including an act of vandalism on Halloween of 1985, restoration work on the Burying Ground continued. A flagpole was erected in 1986 by a local Boy Scout as part of his Eagle Scout Project. The rededication of the Town of Dunn Burying Ground and the dedication of the Veterans Memorial Plaque took place the following Memorial Day.

The Town of Dunn was honored for the outstanding work of the Cemetery Task Force in restoring the Burying Ground to its early Prairie Cemetery state. In 1990, the Madison Landmarks Commission and the Dane County Cultural Affairs Commission presented an award recognizing the Town's restoration of the Burying Ground.

In 2009, as part of his Eagle Scout project, Sam Richards, with the help of Town Staff, identified many of the native wildflowers and had a plaque made and installed at the Buring Ground describing them.

Please enjoy the beauty and peace of the restored Burying Ground. If you look closely you may find the mockorange, shooting star, pussy toe, and trillium blossoms that adorned the Burying Ground when the Beebe Family began burying their loved ones here. In order to maintain the historical beauty of the Burying Ground, the Town mows selectively, only twice per year. This allows the native prairie wildflowers to flourish as they did throughout the early history of the Burying Ground. Please take pleasure in the tranquility of the Burying Ground much as it Appeared nearly two centuries ago.

RESOLUTION 2025-10
RULES AND REGULATIONS
TOWN OF DUNN BURYING GROUND

WHEREAS, the adoption of Town of Dunn Ordinance 18-01 established a system for operation and maintenance of the Town of Dunn Burying Ground, which is a cemetery, and

WHEREAS, rules and regulations are needed to manage and operate such burying ground and rules were adopted by Resolution 94-07,

WHEREAS, the Town established a Green Burial Committee which made recommendations for an update to the established rules and regulations to clarify ambiguous language and to incorporate the practice of biodegradable natural burials,

BE IT RESOLVED that the Dunn Town Board hereby adopts the following rules and regulations for the operation and management of the town burying ground to replace the rules established by Resolution 94-07 and to include burial of caskets, cremations, and biodegradable natural burials without embalming chemicals:

A. Purpose:

These rules and regulations are designed for the protection of owners of interment rights as a group. Their enforcement will help protect the burying ground and create and preserve its beauty. These rules and regulations are hereby adopted as rules and regulations of the burying ground, and all owners of interment rights, visitors, and contractors performing work within the burying ground shall be subject to said rules and regulations, amendments or alterations as shall be adopted by the Town Board of the Town of Dunn from time to time.

B. Definitions:

1. The term "assignment" shall mean the assignment of burial rights by the buyer, or the buyer's heirs, successors, or authorized agent.
2. The term "buyer" shall mean the purchaser of burial rights of interment.
3. The term "Care Fund" shall mean one or more accounts or other investments established for the care of the cemetery in perpetuity.
4. The term "cemetery" as herein used shall mean Dunn Burying Ground or its successors or assigns.
5. The term "burying ground" as herein used refers to the cemetery operated by the town in the Town of Dunn.

6. The term "cemetery lot" shall mean a designated area within a section set forth and appropriately numbered on the master plat of the cemetery consisting of three contiguous graves.
7. The term "cemetery sexton" shall mean the person as appointed by the Town Board under Section 3 of Ordinance 18-1 (Chapter 18 of the General Code of Ordinances of the Town of Dunn).
8. The term "contract" shall mean the written agreement purchasing burial rights to interment.
9. The term "contractor" shall mean any person, firm, corporation or anyone engaged in or performing any work on the cemetery grounds, other than an employee of the cemetery.
10. The term "grave space" shall mean a single burial right that can be purchased within a platted cemetery lot. One grave space can accommodate a maximum of one natural burial and one cremated remains, or one grave space can accommodate one casket and one cremated remains, or one grave space can accommodate up to six cremated remains.
11. The term "interment" shall mean or burial of the remains of a deceased person.
12. The term "memorial" shall mean any marker upon any lot placed thereupon for the purpose of identification or memorialization.
13. The term "officers of cemetery" shall mean the Town Board of the Town of Dunn.
14. The term "owner" shall mean the owner of rights of interment.
15. The term "section" shall mean a designated area within the cemetery, appropriately numbered on the master plat of the cemetery, containing within its bounds cemetery lots and grave spaces as designated.
16. The term "natural burial" shall mean a burial where no embalming chemicals were involved and where only natural, biodegradable materials were used to prepare the body for burial and only biodegradable materials were used in the burial wrapping or container to allow for natural decomposition of the deceased.
17. Monument and planting area shall mean the 48" by 40" area designated for a headstone and plantings. Interments are not permitted in this area unless they are incorporated into the monument itself.

C. Supervision of Burying Ground:

The supervision of the cemetery is under the direction of the sexton.

1. The sexton shall take reasonable precaution to protect the property and markers within the cemetery from loss or damage, but it distinctly disclaims all responsibility for loss or damage from causes beyond its reasonable control, and especially from damage caused by the elements, an act of God, common enemy, thieves, vandals, strikers, malicious mischief makers, explosions, unavoidable accidents, invasion, insurrections, riots, or order of any military or civil authority, whether the damage be direct or collateral, other than herein provided.
2. The cemetery reserves, and shall have, the right to correct any errors that may be made by it, either in making interments, disinterments or removals, placement of memorials, or in inscription, transfer, or conveyance.
3. The right to enlarge, reduce, replat or change the boundaries or grading of the cemetery or of a section or sections, from time to time, including the right to modify or change the location of any cemetery lot or any part thereof or to remove or regrade roads, drives and walks, is hereby expressly reserved as well as is the right to use cemetery property for cemetery purposes. The cemetery reserves to itself, and to those lawfully entitled thereto, a perpetual right to ingress or egress over all lots.
4. All grading, road work, landscape work, and improvements of any kind, and all care of lots, shall be done; and all openings and closing of grave spaces, and all interments, disinterments, and removals shall be made by the cemetery or its contractors.
5. It is the right of the cemetery to regulate the restrictions of each section as to planting privileges and the size and types of memorials and approval shall be obtained from the sexton prior to any work being done.
6. All trees, shrubs and plants of any kind as approved by the sexton shall be planted, trimmed, cut or removed by owner of the grave site or their assigns. If any tree, shrub or plant standing upon any lot, by means of its roots, branches, or otherwise, be or become detrimental to adjacent lots or avenues, or if for any other reason its removal is deemed necessary, the cemetery shall have the right to remove such tree, shrub or plant, or any part thereof, or otherwise correct the condition existing as in its judgment seems best.

D. Burial Rights:

Burial rights in the Town of Dunn Burying Ground are provided in accordance with the procedures hereby established. The lots so provided are with the understanding and agreement that:

1. The Town of Dunn grants buyers and assigns the right to use the lot for BURIAL PURPOSES ONLY.
2. All lots are provided with maintenance and care.
3. Burial rights to not more than six grave spaces may be purchased by any one buyer without prior Town Board approval. A buyer of more than one space may identify which spaces are reserved for specific persons. An owner may elect to make such a designation in writing and the record of such designation shall be maintained by the Clerk/Treasurer.
4. Assignment of burial rights by the buyer of record must be filed with the sexton of the Dunn Burying Ground. The price for assignment of Burial Rights may not exceed the original contract price.

D. Contract:

There will be a contract for every grave space, or a combination of grave spaces on one lot under the same contract. All spaces must be paid for at the time of sale by the purchaser or the funeral home if sale is at the time of need. The price of interment rights on a grave space will be determined by the Town of Dunn fee schedule and 2025 fees are stated in Appendix A.

A contribution to the Burying Ground capital fund will be required for each grave site purchase after September 1, 2025. The amount of the capital fund contribution will be determined by the Town of Dunn fee schedule and the 2025 contribution to the capital fund is stated in Appendix A.

E. Interments:

1. Use of the grave space:
 - a. A grave space in Dunn Burying Ground shall be an area not less than three and one-third feet in width and twelve feet in length.
 - b. The records of sections, lots and graves as recorded at the Office of the Town Clerk/Treasurer shall be considered valid and graves so reported shall not be changed or disturbed except by complying with disinterment procedure.
 - c. A grave space in the Dunn Burying Ground may be used only for the interment of human remains, as a location for an approved monument or memorial to the

persons interred thereon, and for the planting of suitable approved flowers, shrubs and trees.

d. A grave space in the Dunn Burying Ground may be occupied by the remains of only one individual with the following exceptions:

1. Parent/Guardian and child using the same container.
2. Up to three infants can be buried in one grave space.
3. One cremated remains and one remains in casket.
4. Up to six cremated remains may occupy a single grave space.
5. One cremated remains and one natural burial may occupy one grave space.

e. Only the town's approved contractor or the cemetery sexton can dig on the cemetery property including all burials, disinterments, and plantings. This is to ensure accuracy and care for existing gravesites.

2. Interment Procedure:

a. Burial in the Dunn Burying Ground is permitted only upon approval of an application for interment by the cemetery sexton, filed with the Town Clerk/Treasurer. An application for interment shall include:

1. A permit for burial issued by a person authorized to issue burial permits as provided in Section 69.42 of the Wisconsin Statutes.
2. The name and address of the next of kin of the deceased and the name and address of the person authorizing the interment.
3. The section number, block number, lot number and grave space in which interment is to be made.
4. A Disposition of Human Remains Form.

b. The Town of Dunn is not responsible for any errors occurring by reasons of transmission of orders by telephone, email, text messaging or any other means of conveyance, or lack of precise, complete instructions.

c. The Town of Dunn shall not be held liable for accepting an application for interment if the application includes erroneous or illegal information or authorization, and the cemetery sexton may refuse to honor an application if in their opinion there is any doubt as to the correctness and validity of the application.

- d. The cemetery sexton will determine and locate the grave space upon any lot. They may select and open a grave space at their own discretion when proper instructions as to location are not given or when such procedure is necessary in order that a funeral will not be delayed.
 - e. Cement or steel vaults are prohibited for lots purchased after 12/31/2025.
 - f. Sunday and Holiday burials are permitted only upon approval of the sexton.
6. Natural burials are permitted where no embalming chemicals were involved and only natural, biodegradable materials were used to prepare the body for burial and only biodegradable materials were used in the burial wrapping or container which may be a shroud, basket, natural material box or casket, or combination of shroud and container to allow for natural decomposition of the deceased. The deceased in a natural burial may be buried with intact implants, dental work, medical devices, or prosthetics contained within the deceased body at the time of death. The depth of natural burials is 3-4 feet to promote decomposition. Natural burials are permitted on any gravesite in the cemetery and follow the same rules as other burials including requirement for the town or its contractor to do the grave digging. Grave digger may charge an extra fee for natural burials to cover the cost of topping off the soil as needed over time.

F. Disinterments:

Disinterment of cremated remains and deceased embalmed in caskets in the Town of Dunn Burying Ground will be permitted only upon approval of an application for disinterment approved by the cemetery sexton and filed with the Town Clerk/Treasurer. Disinterments are prohibited for natural burials to ensure that the decomposition process is not interrupted. Disinterments by order of the court or legal warrant shall not be prevented by this ordinance and are allowed in accordance with the court order or legal warrant. The application for disinterment shall consist of:

- 1. A disinterment permit.
- 2. A certificate which gives the full name of the remains and a complete description of the location of the grave including section number, block number, lot number and grave space.
- 3. A statement of ownership of the grave space together with the written consent of the owner or next of kin of the grave space, if known and can reasonably be obtained.
- 4. Disinterments will be done only on weekdays, Monday through Friday during normal business hours of 8am to 4pm, excluding holidays.

G. Flowers and Plantings:

In order to ensure a more desirable and uniform appearing cemetery at all seasons of the year, and so that better care may be given to all cemetery grave spaces, the following regulations shall govern all planting. The cemetery is not responsible for the theft or damage to anything placed on the grave spaces. Burying ground staff may move or remove any item left upon any grave space that impedes the operation and care of the cemetery or that may become a projectile, is in disrepair, or is deemed inappropriate. All proposed plantings on grave spaces are subject to the written approval of the sexton and shall conform to the following general guidelines:

1. The planting of perennials or annuals over 36" tall shall not be permitted.
2. The area of planting shall be limited to the front and sides of the marker and shall not extend beyond the 40"x48" designated monument and planting area, and shall not extend beyond the grave space.
3. All spiny, prickly, thorny or large spreading shrubs or bushes are not permitted and will be removed.
4. All urns must be placed next to the markers or in line with other markers.
5. Broken or unplanted urns will be removed.
6. Overgrown, unsightly, dead, detrimental or illegal vegetation, cut flowers or plantings will be removed by the sexton.
7. Winter clean up deadline is November 15 each year. Decorations must be removed by November 15 of each year in preparation for winter operations with the exception of the following allowed winter decorations: Veteran flag holders may remain. Wreaths on thin wire stands may remain. All other items not removed by November 15 each year will be discarded. Cemetery staff may move any item as needed to not interfere with winter operations of the cemetery.
8. Spring clean-up deadline is April 15 each year. Any winter decorations must be removed by April 15 for spring clean-up. If any decorations impede spring clean up, they may be moved or removed by the sexton.
9. Glass containers of any type or unsightly tin cans will not be permitted. Permanent flower vases (pop-up urns) are encouraged.
10. No unattended vigil lights, eternal flames, candles, or other similar contrivances will be permitted.

H. Foundations for Memorials:

Due to regulations and restrictions pertaining to the types and sizes of memorials permitted, it is suggested that the cemetery sexton be consulted before orders are placed. The Town of Dunn reserves the exclusive right to reject all work which, on account of design, workmanship, material or faults of any kind, is in its opinion unsatisfactory.

1. All memorials in the Dunn Burying Ground shall be placed on a foundation and approved by the sexton.
2. All foundations will be installed in accordance with the following procedures:
 - a. All orders for foundations must be in writing and shall be filed at the office of the Clerk/Treasurer of the Town of Dunn not less than fifteen days prior to the placement of the memorial. The order shall show section number, block number, lot number, grave space(s) and accurate dimensions of the memorial.
 - b. Foundations will be even with ground surface and shall be level. Foundations shall extend five inches beyond the base of the memorial on each side and have proper landscaping.
3. Foundations will not be constructed for any memorial to be placed on a grave space that is not paid for.
4. All bronze flush markers are to be mounted on a four-inch thick piece of granite and must have a minimum of 1 and 1/2 inch border of granite exposed with a five (5) inch wash below granite.
5. No laminated wood or wood memorials of any type will be permitted.

I. Placement of Memorials:

Memorials may be placed upon grave spaces in accordance with the following rules:

1. Foundations will be even with ground surface and must be level. Foundations shall extend five inches beyond the base of the memorial on each side and have proper landscaping.
2. On a single grave space: not more than one single raised marker.
3. On two grave spaces: not more than one single raised markers per grave space for a total of two; or in lieu thereof, only one double marker, or in lieu of markers, one monument.
4. On three grave spaces: not more than one single raised marker per grave space for a total of

three; or not more than one single and one double marker for a total of two markers; or not more than one triple marker; or in lieu of markers, one monument.

5. Memorials are to be placed at the head of the grave. Veterans' markers may also be placed on the back of the memorial.

J. Design:

1. The design for each memorial to be placed in the Dunn Burying Ground shall be submitted to the sexton for approval before work on construction of the memorial is started. All memorials and monuments are subject to permission of the sexton. Memorials eligible for approval for placement in the Dunn Burying Ground must be constructed of natural stone or U.S. Standard bronze. All stone used shall be of highest quality first grade, clear stone finished with an exceptionally high-quality workmanship.
2. The design of all memorials to be placed on the Dunn Burying Ground shall conform to the following regulations:
 - b. A single marker shall not exceed 24 inches in length, 12 inches in width, and 36 inches in height, and shall not be less than 12 inches in length, 8 inches in width. Single bronze, ground-level markers shall not exceed 24 inches in length and 12 inches in width and shall not be less than 8 inches in length or 6 inches in width and shall consist of one-piece, exclusive of the concrete base. All bronze flush markers are to be mounted on a four-inch thick piece of granite and must have a minimum of 1 and 1/2 inch border of granite exposed with a five (5) inch wash around granite.
 - b. A double marker shall not exceed 48 inches in length, 12 inches in width, and 36 inches in height, and shall not be less than 24 inches in length, 12 inches in width.
 - c. A triple marker shall not exceed 60 inches in length, 12 inches in width, and 36 inches in height and shall not be less than 48 inches in length and 12 inches in width.
 - d. A monument is defined as a stone or bronze structure which rests on a base, and which exceeds any of the following dimensions: 42 inches in length, 12 inches in width, and 36 inches in height. The term monument may include a bench, bird bath, monolith, obelisk, settee, sundial or urn. A monument shall not exceed an overall height of six feet. The base for a monolith or obelisk shall be a minimum of 12 inches by 12 inches and a maximum of 24 inches by 24 inches square.

K. Memorials, Markers, Monuments, and Stonework:

Due to regulations and restrictions pertaining to the types and sizes of memorials permitted and orientation, the cemetery sexton must be consulted before orders are placed. The Town of Dunn reserves the exclusive right to reject all work which, on account of design (including size), workmanship, material or faults of any kind, is in its opinion unsatisfactory.

1. All memorials in the Dunn Burying Ground shall be placed on a foundation and approved by the Town of Dunn Cemetery Sexton.
2. All memorials will be installed in accordance with the following procedures:
 - a. All requests for memorial installation must be in writing and shall be filed at the office of the Clerk/Treasurer of the Town of Dunn not less than fifteen days prior to the placement of the memorial. The order shall show section number, block number, lot number, grave space(s) and accurate dimensions of the memorial and foundation. A marking fee is due with the request for memorial installation as per fee schedule.
 - b. Installation of any foundation or memorial shall not be placed on a grave space that is not paid for.
 - c. Installation of any foundation or memorial shall not be placed on a grave space that has not been marked out by the cemetery sexton.
 - d. All dimensions are measured from the pitch line (cut line). This is the line that defines the site of the grave, where the grave is dug.
 - e. Workers engaged in placing memorials or doing any other work, shall provide suitable planks on which to move the same, and immediately after the work is completed all rubbish must be cleared away and the ground left clean and in good condition.
 - f. Adjoining lots, paths or roads where work is being done must not be blocked or damaged.
 - g. All workers engaged in erecting memorials or other structures are prohibited from tying ropes to trees, shrubbery or other objects, and are prohibited from cluttering grounds longer than is necessary. The surrounding grave spaces must be restored to their proper condition.
3. No wood memorials of any type will be permitted.

Modifications and Amendments:

1. At any time the Town Board may adopt, and it hereby expressly reserves the right to adopt new rules and regulations or to amend or repeal these Rules and Regulations.
2. Special cases may arise in which the literal enforcement of a rule may impose unnecessary hardship. The town board, therefore, reserves the right, without notice, to make exceptions or modifications in any of the Rules and Regulations when, in its sole discretion, the same appear advisable to avoid hardship and to fulfill the purpose of these Rules and Regulations. Such exceptions or modifications shall in no way be construed as affecting the general application of the Rules and Regulations.

Appendix A

2025 Fees

Interment rights on one grave site shall be \$900, and this payment shall fund the perpetual care and maintenance of the grave site.

The required capital land fund contribution for each grave site purchased after September 1, 2025, through December 31, 2025, shall be an additional \$900 per grave to fund the purchase of additional land as needed to expand the burying ground.

Waiver of the capital fund contribution is available for all current property owners in the Town of Dunn and their family members with a lifetime limit of six waived contributions for the family of the property owner.

Waiver of the capital fund contribution is also available for a previous Town of Dunn property owner and their family members who paid property taxes in the town for a period not less than 10 years in the past and limited to a maximum of six grave sites with waived contribution per family.

2026 Fees

Interment rights on one grave site shall be \$1,000 and this payment shall fund the perpetual care and maintenance of the grave site.

The required capital land fund contribution for each grave site purchased after January 1, 2026, shall be an additional \$2,500 per grave to fund the purchase of additional land as needed to expand the burying ground.

Waiver of the capital fund contribution is available for all current property owners in the Town of Dunn and their family members with a lifetime limit of six waived contributions for the family of the property owner.

Waiver of the capital fund contribution is also available for a previous Town of Dunn property owner and their family members who paid property taxes in the town for a period not less than 10 years in the past and limited to a maximum of six grave sites with waived contribution per family.

APPENDIX A

Price of Lots and Additional Costs

Purchase of Burial Rights (Includes Care & Maintenance): Per Space \$900.00

Locating & Marking Grave Site or Head Stone Per Space:

-normal business hours \$50.00

-after business hours & weekends/holidays \$100.00

Linley Excavating is under contract with the Town of Dunn for the digging of a grave for casket or cremation. Area funeral homes will reach out to Linley Excavating for upcoming funerals, however if you are not using a funeral home you will need to reach out to Linley Excavating for the grave opening and closing. Linley Excavating can be reached at 608-798-2564. Their fees are separate from the grave purchase and marking out fees.

Important Information About Care At The Town Of Dunn Burying Ground

Safety. When mowing and trimming at the burying ground, small items left on and around grave sites become hazardous projectiles for mowing procedures. For the safety of the operations staff, visitors and possible damage to surrounding tombstones, small items will no longer be allowed to be left on or around grave sites at any time. This includes, but not limited to: stones, coins, bottles and cans, knickknacks etc. Items left will be removed and disposed of.

Spring Cleanup to be done by April 15th of each year.

Fall Cleanup to be done by November 1st. All planters (live or fake flowers), hooks, decorations, solar lights, knickknacks, etc. must be removed. Only military flag markers may remain. This is done for winter operations. Items that are not removed will be disposed of.

Christmas wreaths may be placed at the grave on thin wire stands only. NO shepherds hooks. Wreaths may be set at any time.

Grave Dimensions and Layout

All graves are 40 inches wide and 12 feet long. The gravestone area makes up 4 feet and the remaining 8 feet is the burial area of the 12 foot length. All gravestones are placed at the west end of the grave. Graves located in Section 1, Block 1 and Section 2, Blocks 1 & 2 the gravestones face east (if you stand on the east end of the grave looking west) all other graves the gravestones face west (if you stand on the west end of the grave looking east).

Monument & Marker Options

Single Grave: 1 single marker or bench with a maximum size of:

24 inches in length
12 inches in width
36 inches in height

Double Grave: 1 single marker per grave or 1 double marker or bench centered on 2 graves with a maximum size of:

48 inches in length
12 inches in width
36 inches in height

Triple Grave 1 single marker per grave or 1 single marker and 1 double marker or 1 triple marker, centered on 3 graves with a maximum size of:

72 inches in length
12 inches in width
36 inches in height

Monuments Must be approved by the Town of Dunn Cemetery Sexton. A Monument is any stone or bronze structure which rests on a base such as a bench, bird bath, monolith, obelisk, settee, sundial or urn that exceeds any of the following dimensions - 42 inches in width, 12 inches in width, and 36 inches in height. A monument shall not exceed 72 inches in height. The base for a monolith or obelisk shall not exceed 24 inches by 24 inches.

Foundations for markers or monuments must be 5 inches larger on all sides, level and be even with ground surface.
