SECTION 3 – DRIVEWAY CONSTRUCTION REQUIREMENTS

For driveways to be accessed via Town road, driveway plans, specifications, and construction MUST comply with the Town's Driveway Ordinance, 13-2. Below is NOT a comprehensive list. For full specifications, refer to the Town's Driveway Ordinance.

A driveway's length shall be a minimum of 24-feet. For driveways longer than 40-feet in length, driveways shall have a minimum width of 14-feet where the driveway pavement meets the town highway edge.
 All driveways shall have a maximum width of 25-feet.
 Unless a larger culvert is required by the Town or a waiver has been granted, a culvert with a diameter of at least 18-inches and 24-feet in length must be present and accompanied with end walls at the ditch line with a slight dip just before the culvert.
 For concrete driveways, it is recommended that 6-8 inches of asphalt is placed between the edge of the concrete and the beginning of the road to mitigate apron damage.

The undersigned applicant as owner, or as owner's agent, hereby attests they have read a copy of the Town's Driveway Ordinance, that all information provided is true and accurate, agrees to construct the described work in accordance with the Ordinance and plans specifications filed, **AND AGREES TO CONTACT THE TOWN OF DUNN A MINIMUM OF ONE BUSINESS DAY PRIOR TO POURING/PAVING SO THE TOWN CAN VERIFY THE DRIVEWAY IS IN ACCORDANCE WITH THE SPECIFICATIONS FILED.**
